### Visa Note & Fees

#### Tourist

- ✓ The Applicant should have a passport with a minimum validity of six months. (NO Blank passport)
- ✓ One visa form (photocopy allowed).
- ✓ One recent passport-size color photograph.
- ✓ A Covering letter from the Applicant.
- ✓ Confirmed onward/ return air ticket.
- ✓ Hotel confirmation.
- ✓ Traveler's cheque (in original) of at least US\$ 1500 for traveling expenses duly signed by the Applicant or a affidavit from the Bank.
- ✓ An affidavit (attested by a Notary Public) from the Applicant stating that he is visiting Cuba for tourism and he will not undertake any paid or unpaid employment and promise to come back to India after the visit to Cuba.
- ✓ Processing time is 2-3 working days.

- ✓ An invitation letter from the concerned Company in Cuba.
- ✓ Confirmed onward/ return air ticket.
- ✓ Hotel Reservation.
- ✓ Traveler's cheque in original of at least US\$ 1500 for traveling expenses duly signed by the Passenger.
- ✓ Processing time is 2-3 working days.

- ✓ Onward country visa.
- ✓ Traveler's cheque (in original) of at least US\$ 1500 for traveling expenses duly signed by the Applicant.
- ✓ An affidavit (attested by a Notary Public) from the Applicant stating that he is visiting Cuba for tourism and he will not undertake any paid or unpaid employment and will return to India.
- ✓ Processing time is 2-3 working days.
