Visa Note & Fees

Tourist

- ✓ The Applicant should have a passport valid for at least 6 months from the date of application for the visa. If the passport has been renewed, the previous passport should be enclosed.
- ✓ Two duly completed visa forms.
- ✓ Three passport size (45 X 35) mm colored photograph with white background. (face size must be visible 70% - 80%).
- ✓ A Covering Letter from the Applicant, explaining the purpose of travel.
- ✓ A letter from the Company where the Applicant is employed. The Company Profile and proof of registration is also required.
- ✓ Confirmed onward/ return air ticket. Please note that the air-ticket number is used on the visa stamp, therefore the original air ticket is required.
- ✓ Proof of funds is required. They can be in the form of property papers, PAN Card copy, original bank statements for the last 6 months, foreign exchange endorsement in the passport.
- ✓ Applicant's Income Tax Returns for the last 3 years and should be attested by the Notary Public.
- ✓ In the case of sponsored trips the Sponsor in Peru or India should be equally accredited for his/ her financial status, employment and his/her source of income. Alternately, the sponsor should present a written affidavit duly signed and certified by the notary stating his/ her responsibility for the boarding and lodging of the Applicant. The Sponsor should

also take responsibility for the repatriation of the traveler if he/ she acquires an illegal status or does not have sufficient funds to return.

- ✓ Photocopies/ facsimile copies of the documents would not be accepted in any case.
- ✓ Visa issued is valid for 6 months and allows a maximum stay of 90 days per entry.
- ✓ Processing time is minimum 5 working days.

Business

- ✓ The Applicant should have a passport valid for at least 6 months from the date of application for the visa. If the passport has been renewed, the previous passport should be enclosed.

- ✓ Three passport size (45 X 35) mm colored photograph with white background. (face size must be visible 70% - 80%).
- ✓ A Covering Letter from the Indian Business House explaining the purpose of travel.
- ✓ A Letter of Guarantee, written in Spanish duly attested and notarized, from the Business Associate/ s in Peru. It should also be e-mailed to consular@embassyperuindia.in
- ✓ Profile and proof of Registration of the Company employing the Applicant.
- ✓ A Recommendation Letter from the Chamber of Commerce in India.
- ✓ Confirmed onward/ return air ticket. Please note that the air-ticket number is used on the visa stamp, therefore the original air ticket is required.
- ✓ Original bank statements of the last 6 months, of both the Company and the Applicant.



- ✓ Applicant's Income Tax Returns for the last 3 years and should be attested by the Notary Public.
- ✓ Photocopies/ facsimile copies of the documents would not be accepted in any case.
- ✓ Visa issued is valid for 6 months and allows a maximum stay of 90 days per entry.
- ✓ Processing time is minimum 5 working days.
