Tourist

- ✓ The Applicant should have a passport valid for at least 9 months beyond the date of application for the visa.
- ✓ One visa form (photocopy allowed) duly completed and signed by the Applicant.
- ✓ Two passport-size photographs.
- ✓ A Covering Letter from the Applicant stating the reason of travel.
- ✓ A Leave Letter from the Indian Company.
- ✓ If the Applicant desires to authorize a travel agent to submit and collect the passport on his/ her behalf, the travel agent would need to carry an Authority Letter signed by the Applicant, on the employing Companies' letterhead.
- ✓ Confirmed onward/ return air ticket.
- ✓ Original medical insurance for a minimum of 10 days company seal and signature.
- ✓ Onward country visa.
- ✓ Proof of sufficient funds, of at least USD 100 per day per person. A voucher of travelers pre-paid services and copy of the Credit Card may also be produced.
- ✓ Personal Bank Statement updated for the last three months, stamped by the bank.
- ✓ Income Tax Returns for the last 3 years.
- ✓ Hotel reservation or an invitation letter from the organizing Romanian Company.
- ✓ All visa applications are referred to Romania and approval takes about 10 to 15 days.
- ✓ If the Applicant has a valid Schengen visa or a visa for USA, UK, West Europe or Canada, his/ her application can be processed in 4 to 5 working days.
- ✓ Visa is valid for 90 days and is issued for a maximum stay of 30 days.

Note: Effective February 1st, 2014, citizens of countries with which Romania has visa regime, holders of valid uniform short stay visas (with two or multiple entries), long

stay visas or permits of residence issued by Schengen countries are allowed to enter in Romania without a Romanian short stay visa.

- ✓ The mentioned category of non - EU citizens targeted by the new EGO may enter on the territory of Romania for an uninterrupted stay or for more stays whose duration do not exceed 90 days of stay within the 180 day period calculated from the date of the first entry. Business

- ✓ The Applicant should have a passport valid for at least 9 months beyond the date of application for the visa.
- ✓ One visa form (photocopy allowed) duly completed and signed by the Applicant.
- ✓ Two passport-size photographs.
- ✓ A Covering Letter from the Applicant stating the reason of travel.
- ✓ In case of a blank passport, an official Letter of Invitation from the Business Associate/ s in Romania, attested by the Notary Public and the Immigration (Passport) Authority in Romania is required as a support document. Please make sure that it is mentioned in the invitation letter that all the expenses will be borne by the Company in Romania including all reparation.

- ✓ If the Applicant desires to authorize a travel agent to submit and collect the passport on his/ her behalf, the travel agent would need to carry an Authority Letter signed by the Applicant, on the employing Companies' letterhead.
- ✓ Confirmed onward/ return air ticket.
- ✓ Original medical insurance for a minimum of 10 days company seal and signature.
- ✓ Onward country visa.
- ✓ A Covering Letter from the Indian Company recommending travel, the Names and Addresses of the Organization/ s to be visited and the duration of proposed stay is to be enclosed.
- ✓ A Recommendation Letter from the Chamber of Commerce, FICCI or Assocham is also required.
- ✓ In case of a blank passport, an official Letter of Invitation from the Business Associate/ s in Romania, attested by the Notary Public and the Immigration (Passport) Authority in Romania is required as a support document.
- ✓ If the Applicant is a frequent traveler then, an Invitation from the Romanian counterpart should be faxed directly to the Embassy. A copy of the same should be enclosed along with the application.
- ✓ Proof of sufficient funds, of at least USD 100 per day per person. A voucher of travelers pre-paid services and copy of the Credit Card may also be produced.
- ✓ Personal Bank Statement updated for the last three months, stamped by the bank.
- ✓ Income Tax Returns for the last 3 years.
- ✓ Hotel Reservation or proof of accommodation.
- ✓ All visa applications are referred to Romania and approval takes about 10 to 15 days.
- ✓ If the Applicant has a valid Schengen visa or a visa for USA, UK, West Europe or Canada, his/ her application can be processed in 4 to 5 working days.

- ✓ Confirmed onward/ return air ticket.

- ✓ Proof of sufficient funds, of at least USD 100 per day per person. A voucher of travelers pre-paid services and copy of the Credit Card may also be produced.
