Visa Note & Fees

Tourist

- ✓ Visa is not issued.

Family Residence

Note: As per the new rule the visa fees needs to be paid online and not as cash at the Embassy.

For family members joining the husband/ father living in Saudi Arabia.

- ✓ The Applicant should have a passport valid for at least 6 months at the time of application.
- ✓ One visa form (photocopy not allowed).
- ✓ Two color photographs against a white background.
- ✓ An original payment order of SR 2000 paid in Saudi Arabia towards visa fee.
- ✓ A copy of the visa slip.
- ✓ Medical Certificate from an Embassy authorized doctor.
- ✓ In the case of a wife visiting her husband, a copy of the Marriage Certificate is to be submitted.
- ✓ If children below 5 years are joining Parents their Polio Certificate is required.
- ✓ A copy of the Birth Certificate should also be included.
- ✓ The visa can be extended by the Sponsor in Saudi Arabia.
- ✓ Processing time is 4 to 5 working days.

Family Visit

Note: As per the new rule the visa fees needs to be paid online and not as cash at the Embassy.

- The Applicant should have a passport valid for at least 6 months at the time of application.
- One visa form (photocopy allowed in Delhi).
- Two color photographs against a white background.
- A copy of 'Aqama' (Residence Permit) and a copy of the visa slip (to be arranged by the Sponsor).
- Visa is valid for 60 days. Visa can be extend in Saudia Foreign Ministry.
- Processing time is 4 to 5 working days.
- Sponsorer passport copy of the first, second and last page.
- If wife travelling than Marriage certicifcae is required and if child accompanying than polio certificate and birth certificate is required.

Business

Note: As per the new rule the visa fees needs to be paid online and not as cash at the Embassy.

- ✓ The Applicant should have an original passport valid for at least 6 months from the date of expiry of the visa.
- ✓ Two color photographs against a white background is essential.
- ✓ A Recommendation Letter from the Chamber of Commerce. If applying from Mumbai, the letter should come from the Indian Merchant Chamber of Commerce.
- ✓ A Covering Letter from the Indian Organization/ Individual Company, stating details of the business and contact addresses of Business Associate/ s in Saudi Arabia. It is mandatory to have the designation of the applicant, nature of business to be mentioned on the covering letter and a company seal on it.
- ✓ Invitation letter thru Chamber of Commerce (to be arranged by the Sponsor in Saudi Arabia).
- ✓ C. R. (Company Registration) copy of the Inviting Company in Saudi Arabia.
- ✓ Visa is valid for 30 to 90 days and is issued for a stay upto 15 to 30 days. Visa can be extend in Saudia Foreign Ministry.
- ✓ Processing time is 4 to 5 working days.
