Visa Note & Fees

Tourist/ Family Visit

- ✓ Passport, (valid for at least 30 days after the intended stay/departure date from South Africa; at least three unused/blank visa pages).
- ✓ Two recent (not older than 30 days/1 month) passport size, (35 mm x 45mm of the picture) photographs with light or white background. The photographs should have 70-80% face coverage.
- ✓ Fully completed visa application form-(BI84) ? must be completed in black ink and block letters only.
- ✓ Application form-(BI84) - must be signed by the applicant and signature should match the signature on the passport.
- ✓ If the minor child cannot sign the form in that case parents cannot sign, please mention MINOR APPLICANT only.
- ✓ Maiden name in case of spouse it should be the surname which was used before marriage.
- ✓ An original covering letter signed by the Applicant.
- ✓ Proof of financial (Last 3 months bank statement, last 3 months salary advice, Foreign exchange worth USD 1000).
- ✓ Proof of hotel booking, (verifiable) or letter of invitation stating the following: physical address, as well as contact details of the host and host's name and signature;
- ✓ The covering letter and invitation letter should have matching dates.
- ✓ Certified copy of the host's ID or copy of residential status, (permanent residence permit or work permit).
- ✓ Reference/introduction letter from Indian employer. Letter must have the physical address, as well as contact details of authorized signature's name, designation and signature;

- ✓ Vaccination certificate, (yellow fever) if applicant will travel through and stay in yellow fever belt.
- ✓ The High Commission MAY ask for a Repatriation Draft of INR 40,000/- (as security money) in favor of ? SOUTH AFRICAN HIGH COMMISSION? Payable at MUMBAI for DELHI High Commission & in favor of ? SOUTH AFRICAN CONSULATE GENERAL? Payable at MUMBAI for Mumbai Consulate. This money can be collected back by the traveler on his return within two months by showing his passport and the deposit slip of the security money. This is applicable for all Territories.
- ✓ Confirmed return/onward air ticket.
- ✓ Marriage Certificate.
- ✓ Day to day Itinerary.
- ✓ Birth certificate incase of minor.
- ✓ Incase of minor is travelling alone in that case one notarized consent letter should be attached along with the application.
- ✓ Copies of passport bio-data pages (photo page and address/parents page (INDIAN PASSPORTS))
- ✓ Processing time is minimum 10 working days.
- ✓ Visa is generally valid for 3 months.
- ✓ Visa is issued Gratis.

- ✓ An original covering letter signed by the Applicant.
- ✓ Letter of invitation from the South African organizers/hosts stating the name, passport number of applicant as well as purpose and duration of visit. Letter must have the physical address, as well as contact details of the host and host's/authorized signature's name, designation and signature, and Host ID copy attested by commissioner of OATHS (South Africa).
- ✓ The covering letter and invitation letter should have matching dates.
- ✓ Proof of financial (Last 3 months bank statement, last 3 months salary advice, Foreign exchange worth USD 1000).
- ✓ Reference/introduction letter from Indian employer. Letter must have the physical address, as well as contact details of authorized signature's name, designation and signature;
- ✓ Vaccination certificate, (yellow fever) if the applicant will travel through or stay in yellow fever belt.

Transit

Transit visas have been reinstated and as from 1 June 2010, all foreigners from non-visa exempt countries travelling en route the Republic of South Africa to neighboring countries (i.e. the Kingdom of Lesotho, the Kingdom of Swaziland, Namibia, Zimbabwe, Botswana and Mozambique) will be required to be in possession of and to produce a valid transit visa upon entering South Africa.

- ✓ Passport, (valid for at least 30 days after the intended stay/departure date from South Africa; at least three unused/blank visa pages)
- ✓ Two recent (not older than 30 days/1 month) passport size, (35 mm x 45mm of the picture) photographs with light or white background. The photographs should have 70-80% face coverage.
- ✓ Fully completed visa application form-(BI84) ? must be completed in black ink and block letters only.

- ✓ Application form-(BI84) - must be signed by the applicant and signature should match the signature on the passport.
- ✓ An original covering letter signed by the Applicant.
- ✓ Applicant's proof of employment.
- ✓ Documentation stating the purpose of the trip.
- ✓ Valid visa to final destination should be stamped on the passport and copy of the visa.
- ✓ Proof of funds.
- ✓ Vaccination certificate, (yellow fever) if the applicant will travel through or stay in yellow fever belt.
- ✓ The High Commission MAY ask for a Repatriation Draft of INR 40,000/- (as security money) in favor of ?SOUTH AFRICAN HIGH COMMISSION? Payable at MUMBAI for DELHI High Commission & in favor of ?SOUTH AFRICAN CONSULATE GENERAL? Payable at MUMBAI for Mumbai Consulate. - ✓ Confirmed onward air ticket. Return as per tickets to be on or before the expiry of the visa of final destination.
- ✓ Copies of passport bio-data pages (photo page and address/parents page (INDIAN PASSPORTS)).
- ✓ Processing time is minimum 10 working days.
- ✓ Visa is generally valid for 3 months.
- ✓ Visa is issued Gratis.
