Visa Note & Fees

Tourist

- ✓ Visa Application Form filled completely with block capital letters and duly signed by the applicant. (Note) :- For applicant applying in Kolkata and New Delhi VFS (back to back Application Form is to be filled).
- ✓ The Applicant should have a passport (original and copy) valid for at least 6 months upon arrival in Malaysia. Please ensure 3 (three) complete blank pages in the passport for the purpose of visa stamping and approval.
- ✓ Three recent passport-size photographs (35 mm width x 50 mm height), 60-70 % of face appearance against a white background pasted and with full shoulders visible and not stapled on the application form.
- ✓ A typed covering letter from the applicant stating the purpose of travel./ Invitation letter/ supporting document(s) (if any).
- ✓ Confirmed returned air-ticket with flight details & ticket no. (Original and copy).
- ✓ Applicants traveling for the 1st time or hold a fresh passport, need to submit photocopy of the last 3 month updated bank statement (Not applicable to applications submitted in Chennai and Hyderabad)
- ✓ Airlines staff need to submit the confirm return air tickets, open tickets & buddy pass is not acceptable. (Not applicable to applications submitted in Chennai and Hyderabad).
- ✓ Visa is valid from 90 days up to one year at the discretion of the Visa Officer. Single / Multiple entry visas can be issued.
- ✓ Processing time is 4 to 5 working days.

Business

- ✓ The Applicant should have a passport (original and copy) valid for at least 6 months upon arrival in Malaysia. Please ensure 3 (three) complete blank pages in the passport for the purpose of visa stamping and approval.
- ✓ Three recent passport-size photographs (35 mm width x 50 mm height), 60-70 % of face appearance against a white background pasted and wiith full shoulders visible and not stapled on the application form.
- ✓ Confirmed returned air-ticket with flight details & ticket no. (Original and copy).
- ✓ A typed covering letter from the Indian Organization concerned recommending travel and nature of the business.
- ✓ A letter of invitation from corresponding Business Associate/s in Malaysia.
- ✓ Applicants traveling for the 1st time or hold a fresh passport, need to submit photocopy of the last 3 month updated bank statement (Not applicable to applications submitted in Chennai and Hyderabad)
- ✓ Visa is valid from 90 days up to one year at the discretion of the Visa Officer. Single / Multiple entry visas can be issued.
- ✓ Processing time is 4 to 5 working days.

- ✓ Transit visa is granted on arrival for a stay not exceeding 120 hours, provided traveler is holding onward confirmed ticket and an entry visa for next destination.
- ✓ Conditions apply. Kindly check with Malaysian High Commission or Malaysian Airlines before travel.
