Visa Note & Fees

Tourist

- ✓ The Applicant should have a passport valid for at least three months from the date of application for the visa.
- ✓ Two visa forms (photocopy allowed).
- ✓ Two passport-size photographs.
- ✓ Confirmed onward/ return air ticket.
- ✓ An invitation from North Korean national is required through the Ministry of External Affairs.
- ✓ Onward visa and proof of funds.
- ✓ All requests are referred to North Korea and it takes approximately 2 to 3 weeks for approval.
- ✓ Visa is valid for 90 days and is issued for a stay of 30 days for single entry only.
- ✓ Processing time, after the approval is received, is 24 hours.
- ✓ Visa is Gratis

Important : The visa fee mentioned above excludes Kibria's service charge for visa processing.

Business

- ✓ The Applicant should have a passport valid for at least three months from the date of application for the visa.
- ✓ A covering letter from the Indian organization recommending travel.
- ✓ A letter of invitation from the business associates in North Korea to be sent directly to the Embassy.
- ✓ Two visa forms (photocopy allowed).
- ✓ Two passport-size photographs.
