Embassy does not issue Visa currently

Business

- ✓ The Applicant should have a passport valid for at least 6 months from the date of application for the visa.
- ✓ Three visa forms typed neatly (photocopy allowed).
- ✓ Three passport-size photographs.
- ✓ A Covering Letter from the Indian Commercial House giving details of travel.
- ✓ A Letter of Invitation from the Business Associates in Syria attested by the Syrian Chamber of Commerce must also be enclosed. A copy should also be faxed directly to the Embassy.
- ✓ A profile of the Company indicating Business with Syria and copies of invoices etc.
- ✓ A Letter of Recommendation from the Chamber of Commerce (in original).
- ✓ Income tax returns for the last 3 years.
- ✓ Bank statement for the last 6 months.
- ✓ Confirmed onward/ return air ticket.
- ✓ A valid Polio (OPV) Certificate is required.
- ✓ Onward country visa.
- ✓ The Passenger must commit to carry at least USD 500 in cash.
- ✓ Visa is valid for 90 days and is issued for a maximum stay of 90 days.
- ✓ Processing time is 2 to 3 working days.

Transit

- ✓ The Applicant should have a passport valid for at least 6 months from the date of application for the visa.
- ✓ Three visa forms, typed neatly (photocopy allowed).
- ✓ Three passport-size photographs.
- ✓ A Covering Letter from the Applicant/ Indian Commercial House giving details of travel.
- ✓ A Letter of Invitation from the Business Associates in Syria attested by the Syrian Chamber of Commerce must also be enclosed. A copy should also be faxed directly to the Embassy.
- ✓ A profile of the Company indicating Business with Syria and copies of invoices etc.
- ✓ A Letter of Recommendation from the Chamber of Commerce (in original).
- ✓ Income tax returns for the last 3 years.
- ✓ Bank statement for the last 6 months.
- ✓ Confirmed onward/ return air ticket.
- ✓ A valid Polio (OPV) Certificate is required.
- ✓ Onward country visa.
- ✓ The Passenger must commit to carry at least USD 500 in cash.
- ✓ Visa is valid for 90 days and is issued for a maximum stay of 3 days.
- ✓ Processing time is 2 to 3 working days.
