Business

Business visa is denoted by the letter (K) and is issued to Foreign citizens traveling to or residing in the Republic of Tajikistan for business purposes (participation in business negotiations, meetings, symposiums, forums, conferences, tenders, contracts, joint ventures, the study of the Tajik market, participate in auctions, exhibitions and trade fairs, provision of advisory and auditing services, etc.)
