

## Ukraine

### Visa Note & Fees

#### Tourist

**Note:** Personal Presence of the Applicant is mandatory for visa application.

- ✓ Passport must be valid for at least three months after the declared exit date from Ukraine. In case substantial grounds are presented the said requirement may not apply, It must have at least two spare pages and must not be issued more than ten years ago.
- ✓ One Visa form (Photocopy not allowed).
- ✓ Two passport-size photographs.
- ✓ A short-term visa application should be accompanied by one of the following documents:
- ✓ Standardized invitation of a person or entity issued by the regional body or by the state division of the Immigration Service of Ukraine.
- ✓ Invitation from the ministry, other central executive authorities, state institutions, enterprises or organizations.
- ✓ Document confirming family relationship with a citizen of Ukraine or a foreign citizen or stateless person that has permanent or temporary residence permit (such as a marriage certificate or birth certificate).
- ✓ Certificate of the Person of Ukrainian origin and his/her application along with the results of the interview with the Ukrainian diplomatic or consular staff and evidence for Ukrainian ethnical descent or Ukrainian origin of the foreign citizen or stateless person. The spouse and children of the Person of Ukrainian origin, if traveling and staying in Ukraine together, have to submit an application and provide documents confirming family relationships.
- ✓ Document confirming that the nature of travel is tourism in accordance with the Ukrainian Law On Tourism.
- ✓ Invitation from a Ukrainian medical treatment facility.

- ✓ Document confirming that the person is a co-founder of a joint venture or a company (firm, association etc.) representative and that he/she travels to Ukraine to monitor the performance of contracts.
- ✓ Confirmation from the Committee on Humanitarian Aid of the Cabinet of Ministers of Ukraine on the entry of the foreign citizen or stateless person for the purpose of providing humanitarian aid or charity.
- ✓ Invitation from a duly registered religious organization attested by the Ministry of Culture, for short-term stay in Ukraine for religious matters.
- ✓ Petition from the head of a foreign mass media for a foreign correspondent or representative of a foreign media who travels to Ukraine for short-term stay to perform his/her professional duties.
- ✓ Petition from state authorities of foreign states or international organizations.
- ✓ Photocopy of OVERSEAS medical insurance policy + REPATRIATION, evacuation cover. Please carry your original insurance for verification at the time of submission of visa application form.
- ✓ Ordinary visa processing time is 15-20 working days after the day of submission.
- ✓ Express visa is processed within 6-7 working days after the day of submission and costs double price.
- ✓ Visa Application form should not contain any corrections related especially to the name, passport details of the applicant, dates of proposed entry into/exit from Ukraine, number of entries, date of submission and etc.
- ✓ All documents for Ukrainian visa should be submitted in original along with 1 attached copy of each document (copy of application form is not required).
- ✓ An applicant has to submit the copy of the passport with all pages of the passport having any information and the copy of the draft demand from the bank evidencing the payment of the consular fee.

## Business

**Note:** Personal Presence of the Applicant is mandatory for visa application except for those having a valid USA, UK, Australia or New Zealand visa; or has travelled to one of the Schengen countries within a period of last 1 year prior to the date of submission of the documents for obtaining Ukrainian visa.

- ✓ Passport must be valid for at least three months after the declared exit date from Ukraine. In case substantial grounds are presented the said requirement may not apply. It must have at least two spare pages and must not be issued more than ten years ago.
- ✓ One Visa form (Photocopy not allowed).
- ✓ Two passport-size photographs.
- ✓ A short-term visa application should be accompanied by one of the following documents:
- ✓ Standardized invitation of a person or entity issued by the regional body or by the state division of the Immigration Service of Ukraine in Original.
- ✓ Original Invitation from the ministry, other central executive authorities, state institutions, enterprises or organizations.
- ✓ Bank statement for last six months.
- ✓ Income Tax Returns for last three years.
- ✓ Salary slips of last six months.
- ✓ Registration copy of the Ukrainian Company.
- ✓ Photocopy of OVERSEAS medical insurance policy + REPATRIATION, evacuation cover. Please carry your original insurance for verification at the time of submission of visa application form.

- ✓ If the Applicant is holding a blank passport than urgent visa cannot be processed by the Embassy. To apply for the urgent visa it is recommended that Applicant should had traveled to countries like Schengen, USA, Australia, Uk, Canada etc.
- ✓ Ordinary visa processing time is 15-20 working days after the day of submission.
- ✓ Express visa is processed within 6-7 working days after the day of submission and costs double price.
- ✓ Visa Application form should not contain any corrections related especially to the name, passport details of the applicant, dates of proposed entry into/exit from Ukraine, number of entries, date of submission and etc.
- ✓ All documents for Ukrainian visa should be submitted in original along with 1 attached copy of each document (copy of application form is not required).
- ✓ An applicant has to submit the copy of the passport with all pages of the passport having any information/ visas and the copy of the fee receipt from the bank evidencing the payment of the consular fee.

## Transit

**Note:** Personal Presence of the Applicant is mandatory for visa application.

Visa is not required if the Traveler continues the journey by the same or the first connecting aircraft (within 24 hours) without leaving the airport.

Visa is required if the Traveler wishes to leave the airport. It can be obtained from the Embassy in New Delhi. The requirements are as follows:

- ✓ Passport must be valid for at least three months after the declared exit date from Ukraine. In case substantial grounds are presented the said requirement may not apply, It must have at least two spare pages and must not be issued more than ten years ago.
- ✓ One Visa form (Photocopy not allowed).
- ✓ Two passport-size photographs.
- ✓ A transit visa application should be accompanied by one of the following documents:
- ✓ Document confirming the nature of travel is transit (such as a visa to the third country if it is required, a ticket etc).
- ✓ Document confirming the nature of cargo and the nature of vehicle passengers is transit.
- ✓ License for international transportation services issued by the competent authority in the host country.
- ✓ Ordinary visa processing time is 15-20 working days after the day of submission.
- ✓ Express visa is processed within 6-7 working days after the day of submission and costs double price.
- ✓ Visa Application form should not contain any corrections related especially to the name, passport details of the applicant, dates of proposed entry into/exit from Ukraine, number of entries, date of submission and etc.
- ✓ All documents for Ukrainian visa should be submitted in original along with 1 attached copy of each document (copy of application form is not required).
- ✓ An applicant has to submit the copy of the passport with all pages of the passport having any information and the copy of the draft demand from the bank evidencing the payment of the consular fee.
